WHEREAS, pursuant to Article VII, Section 7.1 of the Bylaws of the Association, the Board may increase or decrease the number of Directors by a Resolution, provided that the minimum number of Directors be three (3);

WHEREAS, the Board determined it to be in the best interest of the Association to increase the number of Directors from three (3) to five (5);

WHEREAS, that in order to establish and maintain the staggering of terms once the Board is increased to five (5), four (4) positions on the Board of Directors will be up for election in calendar year 2018 to create staggered terms as follows:

The candidate receiving the highest number of votes will be elected for a Director term of three (3) years;

The candidate receiving the second (2nd) highest number of votes will be elected for a Director term of two (2) years;

The candidate receiving the third (3<sup>rd</sup>) highest number of votes will be elected for a Director term of two (2) years; and

The candidate receiving the fourth (4th) highest number of votes will be elected for a Director term of one (1) year.

WHEREAS, at each annual meeting thereafter, the Members will elect the number of Directors necessary to fill the position on the Board that expire as of such annual meeting, each to serve a term of three (3) years.
